All assets of the Company are domiciled in India and the Company earns its entire revenue from its operations in India. 4. The results for the quarter ended March 31, 2025 are the balancing figures between audited figures in respect of the full financial year ended March 31, 2025 and the unaudited published year to date figures up to December 31, 2024. 5. The above results were reviewed by the Audit Committee and were thereafter approved by the Board at its meeting held on May 26, 2025.
